GIVEN FINES ON WEDNESDAY

Five Delphos Men Arraigned or Charges of Operating Gambling Devices — Cases Disposed of in Justice of Peace Harriet Shappell's Court of Allen County.

Five Delphos men were arraigned Wednesday night in the court of Justice of Peace Harriet Shappell, Bath township, Allen county, on charges of operating gambling devices. Those arraigned were: John IVII, of the Ace of Clubs; S. Arnsberger, of the Brunswick; Evan Wreede, of the Johnson Oil station; George Fisher, of The Club, and Ernest Staup, of Ernie's digar store.

They were found guilty as charged and each man fined \$50 and costs. Each defendant was also placed under a bond of \$500 for a period of one year as a guarantee that they will not operate such devices again during that period.

Their amaignment followed a raid which took place here about two months ago under the direction of Allen county officials assisted by local police. At that time a number of gambling devices were confiscated.

Although Mayor W. D. Swinart requested at that time that the men be arraigned in local court inasmuch as Delphos police assisted, they were removed to the Bath township justice court.

Four Delphos men were fined in Mayor Eiche's court on Monday afternoon as a result of the gambling raid which was made by Chief of Police J. S. Link and members of the police department, Friday.

Those who appeared before Mayor Eiche were, Emmit Snyder, owner of the Club Cigar store, James Bertling, part owner of the Palace, Mrs. Gusta Sowers, owner of the Snack Shop and Louis Rimer, owner of the Playmor alleys.

Each received a fine of \$50,00 and costs on charges of possession of gambling devices in their places of business. Half of the fine was suspended by the mayor, during good behavior.

Chief of Police, J. S. Link, states that no charges were filed against the Checker Club inasmuch as no gambling devices were found at that place.
