



John William Donald, died Mt. Rainier, Maryland (suburb of DC) in 1981 age 82. 1306 I St. NW was the address of the club and 4445 13th St. NE was his residential address. Donald practiced the trade of printing most of his life.

Two raids on the club, over a year apart, both instigated by complaints of players wives (the Herbert Donald mentioned in the articles was John's younger brother):

Washington Post--20jan1937:

Wives' Complaints **Bring Police Raid** On 'Literary Club'

Housewives complained to police that their husbands were losing their wages gambling, so three men charged with setting up a gaming table were taken into custody yesterday when police raided the "Printers". Literary Club," at 1306 I street idethwest. Those charged gave their mames as Herbert Donald, 30, 1996 block Seventeenth street northwest; Thomas B. Reynolds, 29, 1200 block Thirty-first street northwest and John R. Green, colored, 24, 700 block Fairmont street northwest. They were freed on \$1,500 bond.

Sevenissis men, seized when po-lice smashed through a door on the third floor of the alleged gambling establishment, were released as wit-

Led by Sergt. George C. Deyne. the raiders entered the place armed with a United States commissioner's warrant. A quantity of alleged racing slips, dice and card tables were confiscated.

Cept. George M. Little said he has been receiving complaints every day about the place from housewives. The letters, forwarded to him by the District Commissioners, all complained that husbands were losing their wages. Police have raided the building numerous times.

Washington Post--9march1938:

Wives' Letters Bring Gaming Raid on 'Club'

22 Held After 6th Police Invasion of I St. Place.

Five men were arrested and 17 more booked for investigation at Police Headquarters yesterday as a result of a police raid on the Printers Literary Club on the third floor of 1306 I street northwest.

According to Capt. George M. Little, chief of the vice squad, the raid was his answer to letters he has received "from hundreds of wives" who have complained their husbands gambled away their wages.


Led by Sergt. George Deyoe, a corps of detectives and marshals arrived at the club early in the afternoon. They said they had to force an entrance through chicken wire which reinforced the door.

Poker Chips Seized.

The 17 patrons who were surprised in the room were taken to headquarters, booked and released to appear later as witnesses.

Donald, 40, 4445 Thirteenth street northwest, for setting up a gaming table, selling beer without a license and keeping beer for sale; John Robert Green, colored, 26, 909 T street northwest, for two counts of sell-
